Applications for obtaining water connections are made by various industries and investors in Gujarat State for development of their commercial units. Such applications are made before Department of Water Resources, Sardar Sarovar Narmada Corporation, Gujarat Water Infrastructure Limited, Gujarat Water Supply and Sewage Board. The matter of timely disposal of applications by industrial / commercial units in accordance to investments made in the State for speedy connections is done, was under consideration as per the Chapter – 3(4) of the Right of Citizen to Public Service Act, 2013 (RCPS ACT, 2013). The following resolution is made by the Government for replying to the said organizations within the prescribed time limit from receipt of application for water connection.

Resolution:-

When an application is made to the Department of Water Resources, Sardar Sarovar Narmada Corporation, Gujarat Water Infrastructure Limited, Gujarat Water Supply and Sewage Board for water connection, then those agencies shall have to complete the necessary assessment for such application and reply to the applicant regarding the application within the time limit of 60 days.
