Preamble

The Gujarat industrial policy-2015 aims at promoting Gujarat as a globally competitive and innovative industrial destination that stimulates sustainable development and inclusive growth. In view of this strategy the state Government has formulated various schemes to extend support in the form of tax concessions or cash subsidy under resolutions referred above. With view to simplify taxation process, the GST has been introduced in the country with effect from the 1st July, 2017. GST will be in three forms - IGST, CGST, and SGST. On introduction of GST act, the VAT act doesn't remain in operation with effect from 1st July, 2017. The state government reviewed the impact of the changed structure and decided to continue the support to the investment and decided to

amend the provision of VAT concession and allow the SGST concessions.

2.0. Amendment:

After due consideration the government resolutions 2 to 7 read above are amended and the following Para is added under the respective Para under which the provision for VAT incentives is made.

The VAT incentives will be replaced by the SGST incentives and its modalities will be decided separately.

The other terms and conditions of the GRs read above will remain same.
